- 3. The above fees ONLY cover the installation of the new gas service up to the outside meter. Any work and associated cost from the meter and beyond is the responsibility of the homeowner.
- 4. Membership is not mandatory but is strongly recommended. Membership entitles you to a vote at the Annual General Meeting, eligibility to be nominated as a Director, scholarship eligibility for children of members, and discounted rates for service calls.

- 5. This application is subject to approval of the Co-op Board of Directors.
- 6. This application is subject to the approval, of the submission to the Alberta Government Rural Utilities Division.
- 7. In the event that the submission to construct is not approved by Alberta Utilities or in the event that this application is not approved by the Co-op Board of Directors, the parties hereto may agree to leave the monies paid by the Application to the Co-op, pursuant to paragraph 2 hereof, on deposit with the Co-op for a period of (1) one year only.
  - a. If the Parties so agree, the Applicant:
  - b. Shall have the contract price stated in paragraph 2 fixed and the price will not be increased for the said one year period; and,
  - c. The Co-op shall not pay any interest on any deposit submitted by the Applicant to the terms of the Application.
- 8. The Applicant agrees to sign a Customer Contract upon approval of Application and pay in full outstanding amounts due before the start of actual construction.

- 9. The default of the Applicant in complying strictly with the terms of this Application shall leave the Applicant liable for damages and the Parties agree that the deposit pursuant to paragraph 2 shall be considered to constitute liquidated damages for such default.
- 10. In the event that the Applicant, for whatever reason, cancels or withdraws from this Agreement, any cost incurred to the Co-op shall be the responsibility of the Applicant.
- 11. The Applicant hereby grants the Co-op an interest in the lands above described to secure payment of any debts or monies owing pursuant to this Application or any other previous subsequent or collateral contract for the providing of gas or service charges or installation charges and the Applicant authorizes the Co-op to charge the lands above-described by way of Caveat, or easement, or Right-of-Way registered at the Land Title Offices for the Northern Alberta Land Registration District to secure any other right of the Co-op.
- 12. The Applicant shall be responsible for obtaining the U.R.W.'s as required by the Co-op pertaining to this service.
- 13. The Co-op at all times reserves the right to refuse any Application.

Date of install is not guaranteed at any time. Your installation will be done as time and weather permits. Please ensure your application and payment are submitted a minimum of three months prior to commencement of construction.
